The terms and conditions of selection and appointment and other details regarding this occasion are noted below:

- a) The applications are to be made in plain papers stating clearly the credentials of the Group chosen with order of preference of Banks district wise (belonging to the Group only) for being undertaken Audit for the year from 2011-12 to 2013-14. Either Group 'A' or Group 'B' is to be selected by the applicants.
- b) The allocation of UCBs to each Firm would be district wise and locally nearest to the Banks. The selection committee reserve the right to select C.A. firms for any particular U.C.B. of the District.
- c) A list would be prepared and maintained simultaneously for every district by rotation so that the interested C.A. firms in a district can be appointed on rotation basis every year.
- d) The Audit Fees would be governed in terms of Rules 156 and 159 of the West Bengal Cooperative Societies Rules, 2011.

- e) As regard selection and appointment of firms the decision of the committee constituted for the purpose would be final and binding upon the firm. If any choice of banks of a C.A. Firms coincides with other C.A. Firms' choice of Bank, in that case, the selection would be made on the basis of lottery conducted by the selection committee.
- f) The firms applied for allocation of audit of a particular Bank cannot claim it as right for such selection.
- g) No canvassing would be entertained/allowed for such selection by the committee.
- h) The application in a sealed envelope subscribing on the same "APPLICATION FOR SELECTION OF C.A. FIRMS FOR CONDUCTING STATUTORY AUDIT OF CERTAIN UCBs" would be received at the office of the Registrar of Co-operative Societies, West Bengal at above stated address within 15 days from the date of advertisement. C.A. Firms have to quote UCN of R.B.I in the application as well.
